# 2022 SUMMARY ANNUAL REPORT FOR CENTRAL STATES, SOUTHEAST AND SOUTHWEST AREAS HEALTH AND WELFARE PLAN RETIREE PLAN

This is a summary of the annual report (Form 5500) of the Central States, Southeast and Southwest Areas Health and Welfare Plan Retiree Plan (Plan No. 503) having EIN 36-2154936 for the period beginning January 1, 2022 and ending December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Trustees of Central States, Southeast and Southwest Areas Health and Welfare Fund have committed themselves to pay certain health, dental, and vision benefit claims incurred under the terms of the plan.

#### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$2,343,740,303 as of December 31, 2022, compared to \$2,299,414,259 as of January 1, 2022. During the plan year the plan experienced an increase in its net assets of \$44,326,044. During the plan year, the plan had total income of \$197,770,196, including employer contributions of \$340,045,819 and employee contributions of \$48,641,332. Plan expenses were \$243,444,152. These expenses included \$12,729,152 in administrative expenses and \$230,715,000 in benefits paid to participants and beneficiaries.
